A MESSAGE FROM THE PRESIDENT OF THE AMERICAN NEUROTOLOGY SOCIETY Hilary A. Brodie, MD, PhD



s we discuss the changing face of American medicine, foremost in the media and in our own conversations are the changes occurring in the health care delivery system with the implementation of the Affordable Care Act. The attention to this change in the financing of health care in the United States has, to a degree, overshadowed the more impactful burgeoning of scientific breakthroughs and the dramatic advances in technologies. When we look

back 10 years from now, I believe that the effects on patient care and patient health will be far more influenced by the rapid scientific advancements than the financing model. The incredibly successful genomic programs followed by the proteomic advancements and now metabolomics together with the tremendous technological advances are making the field of medicine more exciting now than ever before.

This year's fall meeting will concentrate on these areas of scientific breakthroughs and emerging technologies impacting otology and neurotology. The program will begin with the Franklin M. Rizer Memorial lectureship, which was created to honor a fellow neurotologist who was clearly an early adopter of advancing technologies and innovation. This year's Rizer Lecturer will be Richard A. Chole, M.D., Ph.D. whose talk is entitled "The Chronicity of Otitis: The Role of Bacterial Biofilms". Dr. Chole has been a strong leader in otologic research throughout his illustrious career and has made major contributions to our understanding of bone pathophysiology in the presence of infection and cholesteatoma.

Dr. Adrian James will moderate our first panel who will discuss the advantages and limitations of otoendoscopic surgery concentrating on the controversies of when and when not to use endoscopes. The panel will be comprised of speakers from across the globe who have nurtured this field through its infancy and have developed not only new approaches, but the instrumentation as well to allow for these advances. The second panel will be moderated by Dr. Darius Kohan and will discuss computer-assisted surgical navigation. As imaging resolution improves and the navigation technologies become more accurate, the field becomes ripe for innovative applications. Dr Carol Bauer, a leader in tinnitus research, will moderate a panel on pediatric otology focusing on tinnitus and vertigo. This panel will deal with some of the more challenging issues within otology.

I would personally like to thank the membership of the American Neurotology Society for the great honor to serve the society as its President. Our society is a vibrant, expanding group committed to the advancement of the field of neurotology. If any members are interested in becoming more involved in the society's activities, please contact me, Moisés Arriaga or Kristen Bordignon.

I look forward to seeing you at what promises to be an excellent meeting in Vancouver.

ANS Members Wanted for Journal Article and Book reviews

The ANS and AOS Presidents recently sent a letter appealing for their respective memberships to participate as reviewers. The quality of our journal, Otology & Neurotology depends on active participation by the leaders in the field to review the merits of submissions for publication. We have reprinted the recent letters by Drs. Shelton and Lambert below. Thus far only 35 have responded to the request. As the impact factor and scientific importance of Otology and Neurotology grows, its strength depends on our membership promptly agreeing and completing reviews for the journal. An added benefit for the ANS is that the vitality of the journal comes back directly to the ANS financially supporting our academic mission.

The ANS and AOS are fortunate to own a successful professional journal, **Otology & Neurotology**, which contributes to the educational mission and financial vitality of each Society. A substantial share of the profits is distributed to the two Societies and is used to further their missions. Both the AOS and ANS have established endowments with the intent to fund additional research, and the AOS has already established a new endowed lectureship.

As the journal has grown in submitted reports and international impact, obtaining timely expert peer review has become increasingly important. In order to ensure high quality content, rigorous peer review is critical. The Journal's editor, Dr. John Niparko, reports that it has become increasingly difficult to have manuscripts reviewed on a timely basis, due to the lack of sufficient volunteers.

We all have many requests for our time, and it can be tempting to say "no" to an electronic peer review request. However, the continued success of the Journal hinges upon these reviews and leads to increased opportunities for the Societies, which ultimately benefit our members. <u>It has been a longstanding policy that members of the O&N Editorial Board and the O&N Inc. Board are required to perform 12 peer reviews per year.</u>

If you are already a Board member or a registered peer reviewer, we request that you please accept your assignments promptly and provide your thoughtful reviews on a timely basis. If you are not a reviewer, but wish to contribute to this important professional activity, please contact Marianna Hagan at <u>Marianna.Hagan@wolterskluwer.com</u> to volunteer. If you must choose only one journal to provide peer review, please choose the one that supports our Societies' mission, as this will directly benefit all of us and our specialty.

Otology & Neurotology Reviewer Information: 2011-2013 YTD

- On average, two peer reviewers are assigned to each manuscript
- Reviewers are usually given two weeks to respond to an invitation At the end of the two weeks, if reviewers have not responded, the invitation expires
- Reviewer are usually given two weeks to complete a review, although they can request more time if needed
- Automatic reminders are sent for the following events:
 - 7 days after an initial invitation is sent and there has been no response
 - 5 days before a review is due
 - 3, 7, and 14 days after a review is late
- After a review is 14 days late, manual reminders are sent as needed until the review is submitted or the Editor terminates an assignment.

APPEAL FOR TRAINEE MEMBERSHIP AND NEW TRAINEE MEMBERS

A little-used membership category of the ANS is the Trainee membership status. The ANS Trainee membership category was created in 2004 by the ANS Executive Council with hopes that all Neurotology Fellows, Otolaryngology-HNS Residents, and Post Doctorate Researchers would apply for Associate membership at the close of his or her training. Trainee membership permits residents and fellows to participate in ANS scientific meetings free of charge . This is a great way for residents and fellows interested in Neurotology to get involved in the society, know the newest literature and hopefully become ongoing members of the society when they complete training. There is no cost for this membership category, however, administrative review and approval is required by the Secretary-Treasurer prior to receiving trainee membership. Upon approval, the ANS will provide each Trainee member a complimentary subscription to the O&N Journal for the duration of his or her training. Please provide this information to your fellows/residents. The process is simple and the application is available on the ANS website at www.americanneurotologysociety.com under Forms.

The following qualifications are required for Trainee Membership in the American Neurotology Society.

- 1. The candidate shall have earned a Medical Degree of M.D., Ph.D., or the equivalent.
- 2. In Training in a field of study related to the field of Neurotology (Otolaryngology, Head and Neck Surgery Residency, Neurotology Fellowship or post doctoral research position).
- 3. Special interest in the field of Neurotology
- 4. Highest ethical and moral standards
- 5. Letter from Department Chair and/or Fellowship Director validating Trainee status including Certification of Trainee status and the duration of the program.

Lastly, please inform your fellows/residents of the American Neurotology Society's **"Trainee Award"** for the best clinical or basic science paper in Neurotology submitted by a Resident or Fellow in training in the field of Otolaryngology-Head and Neck Surgery. Residents from any approved residency program or Fellows in Neurotology in the United States or Canada are eligible to compete. The deadline for electronic submission of the full paper (not an abstract) is October 15, 2013. The American Neurotology Society has established a cash award of \$1,000 for the winning paper. The author will be expected to attend the Annual ANS Spring Meeting in Las Vegas, NV on May 16-18, 2014 and present the paper personally.
