# ANS Awards Available Trainee Award (\$1000)

The Society offers an award for the best clinical or basic science paper in Neurotology submitted by Resident or Fellow in training in the field of Otolaryngology - Head and Neck Surgery. Residents from any approved residency program or Fellows in Neurotology in the United States or Canada are eligible to compete.

# The Nicholas Torok Vestibular Award (\$1500)

The Society offers an award for the best lecture on an innovative observation, experience or technique in the field of Vestibular Basic Science, i.e., physiology, pathology or subjects serving clinical progress. The candidate selected by the Committee shall present the "Nicholas Torok Vestibular Award" Lecture at the Annual Scientific Spring Meeting of the Society.

# The Neurotology Fellows Award (\$500)

The Society offers one or more awards to reward scientific excellence. These are intended to subsidize travel expenses incurred while giving a scientific presentation at the annual meeting of the Society. Applicants must be full-time participants in a post-residency Neurotology Fellowship in the United States or Canada. The Fellow must be both podium presenter and first author of the paper submitted for publication.

#### The William House Lectureship

The Society may offer a lectureship to support a scientific presentation by an outstanding neurotologist, neuroradiologist, neurosurgeon, or researcher in an area of interest to neurotologists. This lecture will be given during the ANS Scientific Session at COSM, and is scheduled at the discretion of the President. Coach airfare, a hotel room for up to two nights, and reimbursement for other reasonable travel expenses will be provided. The lecturer is selected by the President.

#### The Silverstein Award

In conjunction with the AAO-HNSF, the ANS sponsors a joint grant for new research investigators in the areas of pathogenesis, pathophysiology, diagnosis, prevention, or treatment of otologic, neurotologic, and skull base diseases and disorders. This matching grant, in the amount of \$15,000.00 per year for two years is awarded based on the eligibility requirements established jointly by the ANS and AAO-HNSF. Applications are reviewed by members of the AAO-HNSF Subcommittee on Research Grants and Prizes, one of whom is an ANS member. The recipient of the grant is announced at the Spring Business Meeting. No publications or verbal presentations are required to result from this award; however, if any do result, they are to be presented at an ANS meeting.

#### The Hitselberger Lectureship

The Society offers a lectureship to support a scientific presentation by a neurosurgeon, neurologist, neuroradiologist or neurobiologist on an area of interest to neurotologists. This lecture is given during the ANS Scientific Session at COSM, and is scheduled at the discretion of the President. A \$500.00 honorarium. coach airfare, and hotel room for up to two nights will be provided. The lecturer is selected by a committee comprised of the President, President-Elect, and William Hitselberger, M.D.

#### The Franklin M. Rizer Lectureship

The Society offers an award for the best lecture in the field of emerging technology in neurotology. lecturer selected by the Committee shall present the "Franklin M. Rizer Lecture" at the Annual Scientific Fall Meeting of the Society and is scheduled at the discretion of the President. The Committee shall consist of the members of the Executive Council. The Society shall award an honorarium to the lecturer selected by the Committee. A certificate or plaque will also be presented.
