#### American Board of Otolaryngology Neurotology Subspecialty Certifying Exam Update

Board The American of Otolaryngology will administer the third Neurotology Certifying exam in Chicago on April 18, 2005. Forty-four individuals have qualified to sit for the half-day oral exam. The format for the Neurotology Subspecialty Certifying Exam is similar to the primary otolaryngology certifying A different examiner exam. evaluates each examinee in 3 onehour sessions. The exam content has been developed based on the Neurotology Body of Knowledge Document that can be found on the ABOto web site (www.aboto. org/).

Eligibility for the Neurotology Subspecialty Certification Exam continues through two pathways. The standard pathway requires the successful completion of an ACGME approved Neurotology Fellowship. The alternative pathway requires seven years of neurotology practice, a two-year operative log of at least 10 intracranial neurotology cases, and authentication by the hospital Chief of Staff. The Alternative pathway remains open until 2012. The application deadline for the 2012 exam is July 10, 2011. Eligibility for the exam in 2013 and thereafter will only be through the standard pathway.

Fifty-two candidates were examined during the second oral examination, April 26, 2004, and fifty passed. ABOto Neurotology Subspecialty Certificates have been issued to seventy-seven Neurotologists.
